(3) POWERS OF THE GENERAL SECRETARY :

- (i) To do all executive work of the Society.
- (ii) To implement all resolutions and decisions of the Executive Committee and General Body.
- (iii) To manage, advice, direct, supervise and control the day administration of the society and its associated organizations and institutions.

(4) POWERS AND FUNCTIONS OF THE VICE PRESIDENT :

In the absence of President, he shall perform all duties of president.

(5) POWERS OF THE GENERAL SECRETARY :

- (i) To do all executive work of the society.
- (ii) To implement all resolutions and decisions of the Executive Committee and General Body.
- (iii) To manage, advice, direct, supervise and control the day administration of the society and its associated organizations and institutions.
- (iv) To appoint and remove persons in the various institutions as per the decisions made by the executive committee or general body.
- (v) The secretary-cum-correspondent shall common and attend all meetings of the general body and executive committee.
- (vi) He shall record proceedings of all such meetings in the minutes book.
- (vii) He shall be incharge of all records and documents of the society.
- (viii) On behalf of the society he shall negotiate, enter into agreements, sign documents etc., with third party or parties with the approval of the executive committee.
- (ix) He shall keep an imprest amount not exceeding Rs.1,000/- at a time.
- (x) He shall prepare periodic reports regarding the activities of the society to be placed before the annual general body meeting.
- (xi) In all circumstances he shall act and discharge his duties, under the directions of the executive committee or general body.
- (xii) He shall prepare and submit the annual budget for the approval of the general body and see that it is approved on or before 30<sup>th</sup> September.

(6) POWERS AND FUNCTIONS OF JOINT SECRETARY :

The joint secretary shall assist the secretary.

In the absence of the secretary he shall act as the secretary.

(7) POWERS AND FUNCTIONS OF THE TREASURER :

- a) He will be incharge of cash account of the society.
- b) The treasurer shall sign all the cheques for the withdrawl of money from banks along with secretary.
- c) The treasurer and the secretary shall obtain the prior permission of the president for expenditure above Rs. 1,000.00 and less than Rs. 5,000.00 and they shall obtain the permission of executive committee for expenditure above Rs.5,000.00.

(8) OFFICE BEARERS

They are the responsible persons to do the activities of the society with the executive committee entrusted to them.



(9) QUORUM :  
2/3<sup>rd</sup> of the total members for general body meeting and 2/3<sup>rd</sup> for executive body meeting.









(10) FUNDS :  
The funds shall be spent only to the attainment of the objects of the society and no portion there of shall be paid or transferred directly or indirectly to any of its members through any means.

(11) AMENDMENTS :  
No amendments or alternate shall be made in purpose of the association unless it is voted by 2/3<sup>rd</sup> of its members present at a special meeting convened for the purpose and confirmed by 2/3<sup>rd</sup> of the members present at a second special meeting.

(12) WINDING UP :  
In case the society has to be wound up the property and funds of the society that shall be transferred or paid to some other institutions with similar aims and objects.
